In the Budget \$4000.00 is allotted for signage Councilor wheeler would like permission from Council to install some signage around town on existing trail heads. Council is in favor.</p> <p><u>EZ Rink Purchase</u>        Council received funding (\$10,000.00) to purchase the EZ rink , the cost of the rink was much higher so a fundraiser was held (Polar Dip) to raise the remaining funds. 
